## Foster Care Provider Requirements

Live in Lincoln, Lyon, Murray, Pipestone, Redwood or Rock County.

Live in a house or apartment which has at least 2 bedrooms and meets fire code for safety reasons.

Be at least 21 years old for Child Foster care, 18 years old for Adult Foster Care.

Be single or a couple.

Have enough income to meet your own family's needs.

Have experience as a caregiver, or be willing to learn if you don't have experience.

Use methods of discipline that do not include corporal punishment.

All household family members welcome having a child in the home.

All household family members support the licensing process.

Agree to keep all information confidential.

Participate in a series of home visits to complete the home study.

Attend required training.

Complete the application materials:

1. Submit to a fingerprint check for all household members age 13 and older.
2. Provide 3 personal references.
3. Submit a statement regarding the physical health of all household members.
4. Complete a health statement for all adults in the house hold.
5. Be free of chemical use problems for at least the past 2 years.

## SWHHS Recommendations

Demonstrate financial and emotional stability, responsibility and a willingness to work closely with the agency.

Have reliable transportation to transport children to appointments (maybe frequently).
