# J. Call to Order

# K. Consent Agenda-

Chairperson Wakefield asked if there were any additions to the agenda. Wakefield asked if anyone had a conflict of interest to identify. None were identified. # M. Caseload-

Director Wilms asked if there were any comments or concerns regarding the caseload. None were stated.

# N. Discussion/Information-

1. Immunization update – Chelsea Self and Renae VanGelderen Two different programs are offered with immunizations. The first program is Minnesota Vaccine for children program. You need to be 18 and under, under insured, Medicaid eligible or not insured. The second program is underinsured or uninsured for adults. The underinsured or uninsured is typically for undocumented aliens. We refer to clinic if they have Medicaid as we like them to see their provider. Vaccines are not ordered ahead of time as vaccines expire and we do not want to waste and throw away vaccines. There is approximately \$70,000 in vaccinations at a time on hand. We can ask for an administration fee but we do not charge for the vaccination. We rarely get fees paid for even the administration fee, as people cannot afford to pay. Undocumented students are referred from clinics or schools. Schools were not required to send in reports to the state during covid so now we are seeing many vaccinations to get schools caught up on student vaccinations. We carry all the required vaccines that schools need. Refugees need certain vaccinations for permanent status in the United States and we carry those as well. There is a lot of paperwork that is done with the vaccinations. The paperwork is held onto for 3 years for audit purposes. There is an extreme amount of monitoring with the vaccinations even before administration. The temperatures of the refrigerators where the vaccinations are kept are done several times a day. There is a refrigerator for children, one for adults, and one freezer. We do vaccines in Pipestone office as well.
