## Funding recommendations for SWHHS Community Health Board -

**MN West** – Motion was made by Chris Lewis to fully fund application for \$45,269.28. Motion was seconded by Stephanie Pierce. Motion passed unanimously.

**Murray County Central** – Motion was made by Commissioner Roskamp to fully fund application for \$179.60. Motion was seconded by Commissioner Burger. Motion passed unanimously.

**Redwood County K9** -Motion was made by Commissioner Wakefield to fully fund application for \$30,000. Motion was seconded by Commissioner Roskamp. Motion passed unanimously.

**City of Tracy PD** – Motion was made by Chris Lewis to deny funding application. Motion was seconded by Heather Bruse. Motion passed unanimously.

**City of Redwood Falls K9** – Motion was made by Commissioner Roskamp to deny funding application. Motion was seconded by Heather Bruse. Motion passed unanimously.



**Lyon County K9** – Motion was made by Commissioner Wakefield to fully fund application for \$1,500/year for 10 years or the life of the K9. Motion was seconded by Commissioner Berger. Motion passed unanimously.

**CentraCare Redwood Falls** – Motion was made by Commissioner Berger to fully fund application for \$76,896.00. Motion was seconded by Commissioner Draper. Motion passed unanimously.

**City of Redwood Falls Drug Task Force** – Motion was made by Chris Lewis to deny funding application. Motion was seconded by Heather Bruse. Motion passed unanimously.

**New Life Treatment Center** – Motion was made by Chris Lewis to deny funding application. Motion was seconded by Stephanie Pierce. Motion failed to pass 12-1. Motion was made by Commissioner Wakefield to partially fund application for the difference of \$175,000 and the total of the rest of the awards. Motion was seconded by Commissioner Draper.

**Round 2 Funding Recommendation:** Discussion was held on the amount to recommend to the SWHHS CHB. A motion was made by Commissioner Draper to request \$300,000 be available for the next grant cycle, likely in Spring of 2024. Motion was seconded by Commissioner Meier. Motion passed unanimously.
